Bowling Alley policies and conditions of rental:

- Teams and individuals must leave the bowling alley promptly to help maintain scheduling.
- There is a maximum number of 36 bowlers in the alley at one time. The party room has 25 chairs.
- The MARC will not be responsible for any lost or stolen items from dressing rooms or elsewhere.
- All Bowling time payments are due in net thirty days. Any outstanding accounts, beyond thirty days from date of billing, shall be assessed a late payment charge on the unpaid balance. Lack of payment will result in a cancellation of any further gym time until the account is paid in full.
- The MARC may cancel bowling rental times anytime in event of special events. Any other situations the MARC management, whenever possible, will notify the representative 24-hours in advance prior to said cancelled bowling time.
- If the renter wishes to cancel rental time a 48-hour notice is required, in writing, to recreation@wabush.ca.
- Any cancellations caused by storms, flooding, power failure, acts of God, or business interruptions caused by mechanical failure of recreation center facilities will be considered unavoidable and representatives will not be charged.
- Renters are responsible for supervision of minors in the MARC recreation center during their rental times and are to keep them from leaving the bowling alley area unsupervised.
- No Food, Drinks, or Outdoor Footwear in the bowling alley area at all times.
- Renters are required to have their own liability insurance. **If you do not have insurance, you will be required to fill out a form to be covered under the Town's insurance policy at an increased rate to be determined based on the nature of the sport/activity and risk assessment provided by our insurance company. (see below document)**
