

# WABUSH TOWN COUNCIL COUNCIL MEETING #19-04 April 18, 2019

TIME AND PLACE

A meeting of the Wabush Town Council was held on Thursday, April 18, 2019, at the Town Hall in Council Chambers. The meeting was called to order at 7:00 pm by Mayor Ron Barron.

### Ms. Rita Pynn

1) The condition of the parking lot of the Menihek Shopping plaza needs to be dealt with. It is within the Towns jurisdiction and is an OH & S safety concern. There is scaffolding left there, doors are blocked with snow and businesses and residents are in danger. The buildings are not being checked by the Town often enough.

The Town responded that it is private property and can not get involved in clearing of a parking lot that does not belong to the Town.

2) Appreciate that snow has to be cleared, however, ice was taken off the roads and pushed so close to her house that it almost came in her front door. Have issue with that. She no longer wants snow pushed on her lawn.

#### Mr. Neil Johnson

The Town is at a critical point. There are big financial concerns with the Town. Once a year is the minimum that residents should be informed of the Towns financial position. Mr. Johnson feels it should be more frequent than that.



Mr. Johnson feels that the Recreation and Aquatics Director should know what their budget is and they do not. Employees should know where the Town stands. There is no trust there. Perception is a big thing. You have to give the perception that everything is good. You have to sell yourself. Mr. Johnson stated that Tacora has a deal with Labrador City. Why doesn't Wabush?

Council stated that the Department Heads are very much a part of the budget process and numerous meetings are had with Dept. Heads during this process. The Finance Committee meet several times a month. Every month Council is provided with an update including an accounts payable list during each Council meeting. As well, any accounts can be run at any time for Department Heads to see where they are in their budget. Council prioritize and make changes if anything is needed. A balanced budget is not easy but Council works with Department Heads for the best interest of the residents. Council knows nothing about a deal with Labrador City and Tacora.
