



The Town of Labrador City has adopted regulations governing the use and care of the cemetery. These Regulations have been developed with the assistance of the Labrador West Ministerial Association.

## Town of Labrador City Cemetery Regulations

- Two gravesites only to be assigned to a family, except in the circumstance when space is required for a child, then three may be granted.
- Urn interment will be permitted under the direction of the Funeral Director.
- All graves in the finished stage, including lawn seed or sods, with the exception of monuments, must be level with the surrounding area, creating a lawn-type cemetery.
- Flowers or wreaths may be placed on graves. Graves will be cleared in the fall of the year. Items of value, such as glass ornamental containers, flower vases, etc. (other than those permanently mounted on headstones) should be removed by October 30.
- The Committee or the Town will not be responsible for damage to headstones or markers caused by vandalism or other factors beyond its control.
- Winter burials will be permitted; however, the Cemetery Crypt will be available. Should the Crypt be used, interment will then take place in early spring. Concerns or questions should be reviewed with the Funeral Director.
- Any structure installed prior to 1999 will be permitted, but if they become damaged or unsightly, they will be removed to maintain the appearance of the area.
- Effective immediately, to aid in the maintenance of the cemetery, no enclosures will be permitted around the gravesites or plots, ie. no concrete, wood or wire enclosures will be permitted.
- Persons found damaging cemetery property are liable to prosecution.
- Dogs are not permitted within the cemetery.

Every effort will be made to keep the access road to the fenced area open all year round.

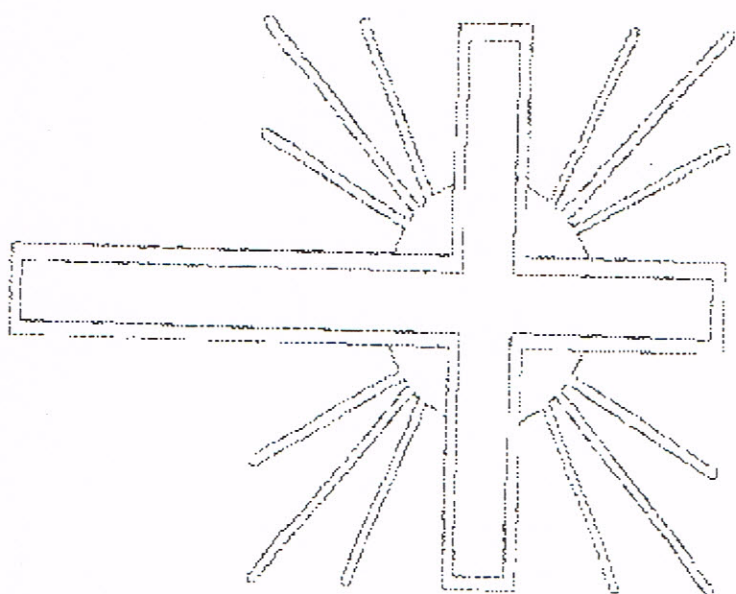
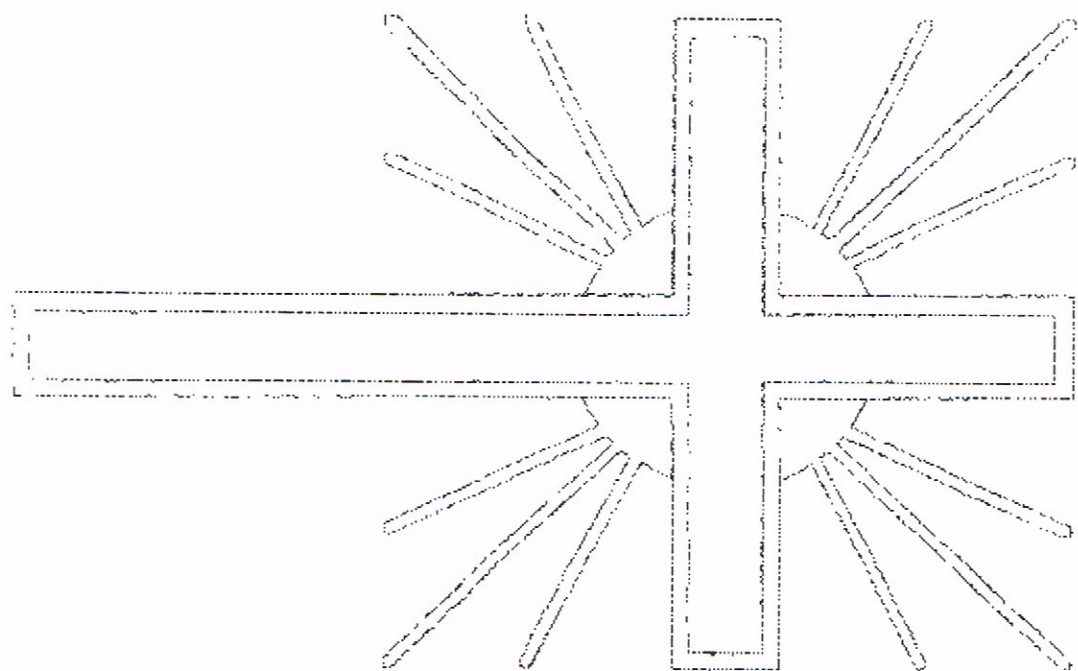
The cooperation of all concerned will be necessary if the cemetery is to remain a place of respect.

**Labrador City Cemetery Regulations**

#### Labrador City Cemetery Regulations

Two gravesites only to be assigned to a family, except in the circumstances when space is required for a child, then three may be granted.

All graves in the finished stage, including lawn seed or sods, with the exception of monuments, must be leveled with the surrounding area creating a lawn type cemetery.

Flowers or wreaths may be placed on graves. Graves will be cleared in the fall of each year. Items of value, such as glass ornamental containers, flower vases, etc. (other than those permanently mounted on headstones) should be removed by October 30.

The committee of the Town will not be responsible for damage to headstones or markers caused by vandalism or other factors beyond its control.

Winter burials will be permitted; however, the Cemetery Crypt will be available. Should the crypt be used, interment will then take place in early spring. Concerns or questions should be reviewed with the Funeral Director.

Effective immediately, to aid in the maintenance of the cemetery, no enclosures will be permitted around the gravesites or plots, i.e. no concrete, wood or wire enclosures will be permitted.

Any structures installed prior to 1999 will be permitted, but if they become damaged or unsightly, they will be removed to maintain the appearance of the area.

Persons found damaging cemetery property are liable to prosecution.

Dogs are not permitted within the cemetery.
