## GENERAL GUIDELINES

1. The above fee schedule is established in accordance with and shall be read together with Policy No. 4.1-12 entitled "Town of Labrador City Fire/Emergency Response Fees."
2. The above fee schedule shall not be applicable if service is otherwise covered under a mutual aid or partnership agreement.
3. Fees shall be charged to the registered owner of the property or any person, firm or corporation having control over or possession of the property or any portion thereof, including a property manager, mortgagee in possession, receiver, manager, trustee or trustee in bankruptcy.
4. In order to recover full payment of the stipulated fees, for emergency response to motor vehicle incidents involving a non-resident driver who is neither a property owner nor a tenant of property within Labrador West, fees shall be applicable to any one or combination of the following: non-resident driver, vehicle owner and insurance company.  
Note: Labrador West includes Labrador City and Wabush. If two vehicles are involved - they split the cost.
5. All consumables utilized during the response will be billed at cost together with a surcharge of 20%.  
example: foam, absorbents, hose lines, bunker gear damaged or destroyed, meals, etc.
6. All pricing subject to HST.
