#### NEW BUSINESS Deputy Mayor O'Brien

On-line registration is being looked into. No promises for January registration.

More Christmas decorations are needed. Town Manager stated that two new larger pieces are ordered. Mayor Barron requested that we plant our own Christmas trees to be decorated yearly rather than purchasing or cutting down trees.

Councillor Razi

Shortage of Doctors – residents waiting at Emergency for hours at a time to refill prescriptions is not acceptable. What can we do as a community to recruit and retain doctors? A nurse practitioner at \$60 per visit not covered by MCP is not a solution. IOC has a virtual doctor app but only IOC employees can avail of it.

Councillor Pynn said shortage of doctors is a provincial problem brought up at the MNL conference.

Mayor Barron said recruitment has to start early. Investment in students to grow our own doctors (financially help with school etc.). Councillor Razi also stated that there is a need for these seats in school to be specifically designated for Labrador students only. Discussion on the inadequate Medical Assistant Travel and how the government knows that it is not working. Labrador-Grenfell Health has recruited but they end up outside of here due to several factors. Housing for anyone looking into the area is a major issue as well.
