FINANCE Loan Approval – Amended

Be it so moved and seconded that Council approve a loan from the Bank of Montreal in the amount of \$431,843 (taxes excluded) to purchase a 2022 Komatsu Loader. The term of the loan will be 5 years at an interest rate of 5.99% with monthly payments of \$8.346.73. Previous motion from November 17th will be

rescinded.

Interest rate lowered so the amounts didn't match the original bank letter.

Town Manager informed Council that the loader is ready, just waiting on the CAT attachment. Amended motion will be sent to Municipal Affairs tomorrow.

Be it so moved and seconded that Council approve the land sale at 92 Bond Street as per request.

This land is already occupied with a trailer, it is one of the few properties that is covered under the old Wabush Mines leases. As the trailers sell that still have these leases, the town is conveying over the land.
