Correspondence dated November 24, 2022 was received from the Department of Municipal & Provincial Affairs advising that the CCBF (Canada Community Building Fund)

Committee has accepted the Town's revised Capital Investment Plan as Road Upgrade – Tamarack Extension, Project No.: 129-2020-7257. Approval under the CCFB is \$76,548.00, for the total approved of \$2,095,480.00.

The Town has \$310,980.96 remaining in CCFB to March 31, 2024 to be allocated toward projects. To access these funds, please submit a Capital Investment Plan Application, resolution of Council, and a quote for the proposed cost of the eligible project.

5.2 Local 10 Digit Calling Coming to NL

Starting April 1, 2023 local 10-Digit dialing will be introduced in Newfoundland & Labrador (709 Area Code), northern Ontario (807 Area Code), and the three exchanges of Yellowknife. Residents will need to dial 10 digits, the area code followed by the sevendigit phone number for ALL local calls.

The introduction of 10-digit dialing is the result of a decision by the Canadian Radio Television and Telecommunications Commission (CRTC).
