After receiving tenders for the Supply of One New Rescue Apparatus in Dec 2022 which were quoted higher than expected, and tender was cancelled, discussions around purchasing new or used have been had and many contacts reached out to on availability; Bryan Fagan (member of the Fire Dept and a Heavy Duty Mechanic by trade) will travel to Quebec to look at options they have found and report back to help make best decision.

c) Bristol / Campbell Proposed Change in Traffic Flow
