Correspondence from the Department of Transportation & Infrastructure, dated May 23rd, 2024, was received providing approval to award a tender of Project No.: 17-GI-24-00043 Tamarack Sanitary Sewer Upgrades – Option 2, to Enercon Builders Inc in the amount of \$877,462.87 hst inclusive.

6.1 Department of Transportation & Infrastructure – Project Overruns: Tamarack Sanitary Sewer Upgrade – Option 2

a) Canada Day

b) Men's Softball Filed Update

A lot of work has gone into preparing the filed and it should be ready for use July 1st, 2024 as promised. We are still working on grass growth, infield preparation and will install the new foul lines in time for the start of the season.

c) Acoustic Panel Installation

The new acoustic panels will arrive in Labrador City late June with an early July installation planned. We are extremely excited to have the new panels in place and will then focus on the new sound system before the start of the ice season.

d) Playground Installation

Installation of the new piece of playground equipment is moving along nicely, we are now awaiting the rubber surfacing to go around the unit. Residents are reminded to be safe and follow the safety notices in place; we will communicate once the unit is opened and ready for use.

7.3 Municipal Services

a) Willow Drive – Phase 1 Update

The project has been awarded to Grey Rock with an anticipated start date of Tuesday, July 2, 2024. We are waiting on the construction schedule then we will hold the kick off meeting to get this project started.

b) Tamarack Trunk Sewer Update

The project has been awarded to Enercon Builders Inc, kick off meeting and signing of documents are being scheduled. We are also applying for additional funding to help offset cost overruns on this project.

c) Town Hall / Fire Hall Emergency Generator

The generator has arrived on site and we are in the process of getting H&F Electrical, through Enercon Builders, to arrive on site to complete the hook up and testing process.
